


SYLLABUS FEEDBACK– ACTION TAKEN REPORT

Government College, Nedumangad, established in the year 1981 is affiliated toUniversity of Kerala. The curriculum and syllabus adopted by the college are designed and developed at the University level by the Academic Counciland respective Board of Studies. The University of Kerala follows Choice Based Credit Semestersystem (CBCSS) for its programs. The college IQAC collects syllabus feedback from various stakeholders - Students, Teachers, Parents and Alumni .The feedback collected is analysed and submitted to the college academic council for taking necessary actions.

Feedback Summary

1. Students Feedback

The feedback from 724 students was collected and the opinion on various aspects related to curriculum are measured in a five point scale (poor-1, average-2, Good-3, Very good-4, Excellent-5) and the results are presented below.

The overall opinion about the syllabus and academic facilities by students are good. However the students need further improvement in academic environment and research facility. The need for conducting internal exams on time and syllabus coverage before exams is suggested by some students.

2. Teacher Feedback

A stratified random sampling of 25 teachers was conducted by taking each department as strata. Teachers' opinion on various objectives are measured in a five point scale (poor-1, average-2, Good-3, Very good-4, Excellent-5) and the results are presented below.

The overall opinion of teacher's regarding Academic environment, Research facility and innovative teaching methods adopted is good. Some faculty members are part of University board of studies and academic council. They will suggest necessary change in the syllabus based on contemporary developments in the field of study.

3. Alumni Feedback

The Opinion of Alumni on the syllabus was obtained through stratified random sampling on 35 units, by assigning each department as strata. The survey delved into various aspects of the syllabus and evaluated each aspect in a 5 point scale (poor-1, average-2, Good-3, Very good-4, Excellent-5). They expressed good opinion about the over all quality of education and relevance of the syllabus. But were neutral about the evaluation mechanism.

4. Parent Feedback

The Opinion of Parents on the syllabus was obtained through stratified random sampling on 50 units, by assigning each department as strata. The survey delved into various aspects of the

syllabus and evaluated each aspect in a 5 point scale (poor-1, average-2, Good-3, Very good-4, Excellent-5). The data was analysed using descriptive statistics tools and is presented below.

The parents were satisfied on the educational infrastructure of the institution. However they suggested an improvement in the conduct of internal exams.

Decisions taken and implemented:

Based on the feedback received from students, teachers, parents and alumni, the college academic council has decided to take the following remedial actions:

- 1. All departments were asked to submit the syllabus completion report before 5^{th} of every month.
- 2. Unified timetable for the conduct of internal exams for all departments. The internal exams are to be conducted in the pattern of University exam. The result of the internal exams is to be submitted within one week after the conduct of all exams.
- 3. The department wise programs like seminars, workshops and other events are to be displayed in the college notice board and website.
- 4. A Question bank for students has to be maintained by every department.
- 5. Regular conduct of PTA meetings and the parents should be informed about the results of internal exams.
